JURIED ART EXHIBITION ELIGIBILITY REQUIREMENTS & INSTRUCTIONS

ENTRY FEE: \$10.00 PER ENTRY - LIMIT OF THREE ENTRIES per each category;
Painting/Pottery. Donation of one piece for the ART AUCTION waives the entry fee for that piece and guarantees inclusion into the exhibition and the judging of awards.

ELIGIBILITY: This exhibition is open to all artists in the categories of **PAINTING**, which includes oil, acrylic, watercolor and mixed media and **POTTERY**, functional and non-functional pieces. All work must be the original creation and composition of the submitting artist. There is no age limit on the artwork, it may be **Old or New**.

SIZE REQUIREMENTS FOR ENTRIES: Maximum framed size: perimeter must not exceed 120 inches (the total inches of each side added together.) **All work must be framed** (unless the work is on a 2 inch Gallery Wrap Canvas or 2 inch Deep Cradled Painting Board such as Ampersand Gessobord or similar product quality) **and ready to hang. Screw eyes and wire only.** Pottery pieces no larger than 16 x 16 x 16 or in general fitting within these parameters. The piece may be taller and narrower and less deep but the general total inches will add up to the 16 x 16 x 16 requirement. **If Pottery is to be hung it must have hangers appropriate to the weight of the piece. Painters/Potters must have an identification card on the back of each piece with your name, address, phone number, title of piece and sales price.**

JURYING: Selection will be by digital imaging JPG format for inclusion in the exhibit. Artists whose works are accepted will ship or bring the original work for inclusion in the exhibit and the judging of awards to **Latah Valley Presbyterian Church, 202 E. Meadow Lane Rd., Spokane, WA 99224.** **Latah Valley Presbyterian Church and Studio B - Heartworks Gallery** reserve the right to refuse any artwork that they deem inappropriate to the space for the exhibition, is improperly presented, unsafe, damaged or not the same as represented in the digital image submitted for judging. **NO** withdrawals or substitutions will be accepted after a work is juried into the exhibit.

DIGITAL ENTRIES: Each artist may submit three (3) entries in each category; Painting/Pottery. Digital entry files must be in JPEG format on a CD (compact disc). Submit **one image per entry** with a minimum resolution of 640 X 480 or 150dpi. More than one entry may be on your CD. The image must be oriented correctly (vertical or horizontal). Title the image file: artist first initial, last name, first two words of title.jpg Ex: JDoeAutumnSea.jpg Do not use spaces or punctuation except .jpg at end. Label your CD using a permanent marker, with your name and phone number. **The CD will not be returned unless accompanied by a self-addressed and prepaid postage return envelope.** **DO NOT SEND ORIGINALS!**

ACCEPTANCE & NOTIFICATION: All digital entries must be received no later than **AUGUST 20TH.** **Any exhibitor information received after the DEADLINE of AUGUST 20TH will automatically be declined.** Notification will be mailed to each entrant no later than **SEPTEMBER 10TH**, indicating which works were accepted or declined. **There is no refund of fees for declined pieces.**

DELIVERY OF ACCEPTED WORK: All accepted artwork must be received at **Latah Valley Presbyterian Church, 202 E. Meadow Lane Rd., Spokane, WA 99224** **SEPT. 20 - 24** from **2:00 to 5:00 PM daily.** If works are shipped **they must be shipped with return prepaid postage included.**

RETURN OF WORK: **Work not shipped must be picked up from the church NOVEMBER 1ST, 10 AM to 5:00 PM.** Shipped work will be packed and returned to the artist beginning the week of **NOV. 1st.**

SALES: Interested persons will be directed to you the artist so that you may make the sale of your work.
